

"W/P/S - LIVE Lockdown MAN vs MACHINE" FREEROLL Tournament - Rules & Regulations

1. W/P/S – LIVE Lockdown MAN vs MACHINE is a game of skill, for active account holders ONLY, with ADW wagering activity mandated on the day of this tournament. The object of W/P/S – LIVE Lockdown MAN vs MACHINE is to utilize a \$50 mythical bankroll via win, place, show wagers, and compile the highest total accumulative total of mythical winnings. Official race results and pari-mutuel payouts are applied to mythical contest wagers to determine winners, tournament players have until 0 MTP to enter picks in respective/applicable tournament races. The main objective is to accumulate more pari-mutuel winnings than other competing horseplayers, as well as THE MACHINE.
2. Players who enter successful contest wagers will have the payout added to a separate “winnings” bankroll. Contestants with the highest total bankroll will qualify for the 1st & 2nd place prize. At least ½ of each W/P/S – LIVE Lockdown MAN vs MACHINE contest will be New York racing content. Account holders MUST have wager activity through their participating ADW account on the day of this contest to qualify for any prizes.
3. Participating contestants are mandated to have one (1) and only one (1) mythical wager in every race of the contest. Players will only have the option to enter a mythical wager from the \$50 bankroll – subsequent winnings from that \$50 bankroll will not be applied for wagering purposes in the contest. Any of the \$50 mythical bankroll left over at the end of the contest will not be applied to the winnings that determines contest winners. IE – if a player has \$10 left over after the final race, it will not be applied to the winnings listed on the contest leader board. The top 2 competing horseplayers will receive a FREE seat (\$25 value) in the upcoming PAYDAY tournament, regardless if they beat THE MACHINE. If either of the top 2 finishers beats THE MACHINE (higher final winnings total), they will receive an additional award of 10% of their final remaining bankroll (capped at \$100).
4. Players will have a primary selection, and a secondary selection for backup in the event of scratches/changes. If both selections being scratched, the player will inherit post time favorite (of whatever bet they placed – IE, a \$4 win bet – they inherit the favorite to Win for \$4)
5. Players must place a tournament wager in every race or face a penalty. Players that do not place at least a \$2 wager in each race will be penalized \$5 from whatever is left in their bankroll. If less than \$5 is left in their bankroll than \$25 is deducted from their winnings. (IE – if a player bets \$50 in race one and wins \$250, \$25 will be deducted from their bankroll for each remaining race in the tournament). If a player skips race one, \$5 is deducted from their bankroll leaving them with \$45 dollars. Win/Place>Show payouts will be capped at 20-1 within the system. So if a player bets \$20 on a 30-1 entry, the most they can earn for the tournament is a 20-1 payout.
6. Deadline to register for W/P/S – LIVE Lockdown MAN vs MACHINE is 9am the same day of the contest. If the account cannot be verified or is not in good standing, the registrant will be purged from competition. W/P/S – LIVE Lockdown MAN vs MACHINE contests will open by 10:30am the same day of the contest. The deadline to enter/cancel selections is the (contest races) race post time. If your 1st and 2nd selection is scratched, you will be awarded the post time favorite in that respective race and wager. If the post time favorite is a coupled entry the contestant receives the entire entry and is credited with the best result of the horses that make up that entry in the applicable wagers. If a contestant selects a wager that is no longer available in a contest race due to scratches, and/or disqualification, the amount of that wager is refunded the player’s contest bankroll.
7. All W/P/S – LIVE Lockdown MAN vs MACHINE contests will feature New York based racing in at least 50% of the participating entry fields. In the event of a cancellation, the contest also ends and all selections are voided. All prizes will be carried over to the next online W/P/S – LIVE Lockdown MAN vs MACHINE contest. If a 1st place tie of total pricing for successful participants, the players which tied will each receive a paid entry to the weekly PAYDAY tournament. IE – 2 players tie for 1st, they will each receive a paid entry. If a tie of total pricing for additional participants, the prize/s will be awarded to the player that submitted their final series of selections 1st on the contest timeline.
8. In the case of a dead heat, official race results will determine if an entrant's selection is successful. (Example: If there is a two-horse dead heat for show, a minimum of four horses would be declared successful in meeting one of the contest requirements of finishing first, second or third, scoring will be based on resulting pari-mutuel payout). Disqualified entries are eliminated from competition, and players with DQs do not inherit the post time favorite.
9. If no individual entrant successfully chooses any mythical wagers in each race in the contest, nothing is awarded and contest prizes are carried over to the following W/P/S – LIVE Lockdown MAN vs MACHINE online contest.
10. Any effort to submit multiple selections under an assumed name or account number, or to otherwise defraud this contest subjects contestants to immediate elimination. All contest results are final and binding in all respects, all decisions by contest management are final.
