

## **"MAN vs MACHINE" Winners Take All - FREEROLL - Rules & Regulations**

1. MAN vs MACHINE Winners Take All - FREEROLL is a game of skill, for active account holders ONLY. The object of MAN vs MACHINE Winners Take All - FREEROLL is to utilize a \$50 mythical bankroll via win, place, show, exacta, or boxed exacta wagers to accumulative the highest accumulative total of mythical winnings. Official race results and pari-mutuel payouts are applied to mythical contest wagers to determine winners, tournament players have until 0 MTP to enter picks in respective/applicable tournament races. The main objective is to accumulate more pari-mutuel winnings than other competing horseplayers, as well as THE MACHINE.

1A. Participants who enter successful contest wagers will have the payout added to a separate "winnings" bankroll. Contestants with the highest total bankroll in comparison to their fellow tournament players as well as THE MACHINE will be determined the winner/s. At least  $\frac{1}{2}$  of each Winner Takes All contest will be New York racing content. **Account holders MUST have wagered activity through their account on the day of this contest to qualify for any freeroll prize.** A \$50 bonus will be awarded to players that submit a live entry in each and every race within the tournament, this includes entries from THE MACHINE. IE - if there are six (6) races in the tournament, and a player enters a W/P/S or exacta pick in every race, a \$50 bonus will be awarded to that players' bankroll at the end of the tournament. Tournament wagers that are refunded due to scratches, disqualifications, or if wager type is not available will not qualify as a live entry for these purposes.

2. The top 2 competing horseplayers will receive a FREE seat (\$25 value) in the upcoming PAYDAY tournament, regardless if they beat THE MACHINE. If either of the top 2 finishers beats THE MACHINE, they will receive an additional award of 10% of their final remaining bankroll (capped at \$100).

3. Participating contestants are not mandated to have mythical wagers in every race of the contest. Players will only have the option to enter mythical wagers from the \$50 bankroll – subsequent winnings from that \$50 bankroll will not be applied for wagering purposes in the contest. Any of the \$50 mythical bankroll left over at the end of the contest will not be applied to the winnings that determine contest status. IE – if a player has \$10 left over after the final race, it will not be applied to the winnings listed on the contest leader board.

4. Participation is free for all account holders. The deadline to enter selections is the (contest races) race post time. If your selection is scratched, you will be awarded the post time favorite in that respective race and wager. The deadline to cancel wagers is also the applicable races' post time.

5. If a contestant selects an entry prior to the selection being announced as a scratch or as a non-starter for pari-mutuel wagering purposes or a contestant's selection is a scratch or declared a non-starter for pari-mutuel wagering purposes at any point, the contestant will receive the post time favorite in that respective race. If the post time favorite is a coupled entry, the contestant receives the entire entry and is credited with the best result of the horses that make up that entry in the applicable wager/s.

6. If a contestant selects a horse that is part of a coupled entry or mutuel field, each of the entries fall under that selection. If a contestant selects a wager type that is no longer available in a contest race due to scratches, and/ or disqualification, the amount of that wager is refunded the player's contest bankroll.

7. All MAN vs MACHINE Winners Take All - FREEROLL contests will feature New York based racing in at least 50% of the participating entry fields. In the event of a cancellation, the contest also ends and all selections are voided. All prizes will be carried over to the next online MAN vs MACHINE Winners Take All - FREEROLL contest. In the event of a tie of total pricing for successful participants, the prize will be awarded to the player that submitted their final series of selections 1<sup>st</sup> on the contest timeline.

8. In the case of a dead heat, official race results will determine if an entrant's selection is successful. (Example: If there is a two-horse dead heat for show, a minimum of four horses would be declared successful in meeting the contest requirement of finishing first, second or third for a SHOW wager). Disqualified entries are eliminated from competition.

9. If no individual entrant successfully chooses any mythical wagers in each race in the contest, nothing is awarded and another free entry is carried over to the following MAN vs MACHINE Winners Take All - FREEROLL online contest.

10. Any effort to submit multiple selections under an assumed name or account number, or to otherwise defraud this contest will lead to immediate elimination. All contest results are final and binding in all respects, all decisions by contest management are final.
